1. POSSIBLE CHANGES TO THE MEETING AGENDA

The agenda was unanimously approved.

2. MINUTES OF THE PREVIOUS MEETING AND TASK REVIEW

The MoM of CIIRC Assembly No. 18 were unanimously approved.

3. PROGRESS ON THE CIRC BUILDING

The contract between the CTU and the supplier (Hochtief) was signed on October 15, 2014.

The "Chinese Laboratory" was closed and sealed on November 5, 2014.

The building site was handed over to Hochtief on November 6, 2014.

The CIIRC buildings will be ready in 420 days.

4. PROGRESS ON THE CIRC VAVPI PROJECT

The foundation stone tapping ceremony will take place on November 24, 2014.

The Minister of Education has not signed the contract yet.

CIIRC is processing additional documents for the Ministry of Education.

It is essential to start building teams.

CIIRC has no space for the researchers – the rector offered building C at Karlovo nam. to CIIRC, which would fit about 25 researchers.

The rector's order regarding the distribution of responsibilities for the project execution is needed (e.g. the responsibilities of the bursar, rector, deans,...).

The Academic Senate will discuss CIIRC on December 17, 2014.

The rector's office will be located at CIIRC building.

The team leaders received new plans of the team location in the new buildings.

CIIRC will follow VaVpI rules.

OP VVV does not allow building new infrastructure.

VaVpl team will meet with the program leaders regarding their plans for 2014 and 2015 and the devices

Some of the CIIRC researchers will be seated in Certicon in Dejvice – 550 m².

CIIRC will sing a contract with EATON regarding a shared office.

The members of the CIIRC Assembly will send the rector an official request to take action.

5. CONTRACT AMONG FACULTIES AND INSTITUTES

Directors of the CTU institutes protested against the rector's order regarding the cooperation among faculties and institutes.

The following issues have to be resolved: teaching, employment sharing, overheads, RIV points.

6. INTERNAL BUDGET AND FINANCIAL STRATEGY

Will be discussed at the next meeting of the CIIRC Assembly.

7. INFORMATION ABOUT THE PROGRESS OF ATTESTATIONS

The meeting of the Attestation Committee took place on October 14. Six new applications have been submitted and processed.
