1. POSSIBLE CHANGES TO THE MEETING AGENDA

The agenda was unanimously approved.

2. MINUTES OF THE PREVIOUS MEETING AND TASK REVIEW

The MoM of CIIRC Assembly No. 19 were unanimously approved.

3. PROGRESS ON THE CIRC BUILDING

The foundation stone tapping ceremony took place on November 24, 2014.

Operation meetings of technical representatives ("Kontrolní dny") take place regularly every week.

The CTU and Hochtief are to sign an amendment to the contract.

The construction continues as planned.

The Minister of Education has not signed the contract yet. CIIRC has processed additional documents required by the Ministry of Education.

VM was asked to provide a calculation of operation costs of CIIRC/m².

CIIRC will use 7 offices in Building C at the Charles Square starting January 1, 2015.

Some of the CIIRC researchers will be seated in Certicon in Dejvice – 550 m².

The issue of the spectrometer for the Faculty of Nuclear Sciences and Physical Engineering has been resolved.

8-10 employees of the FEE plan to have shared workload (FEE and CIIRC). The FEE is not in favor of this solution.

CIIRC has obtained two grants from the Czech Science Foundation (GA CR).

The Centre for Applied Cybernetics will be transferred to CIIRC in 2015.

At the moment CIIRC has 20 FTE. Starting January 1 CIIRC is to have 30 FTE.

CIIRC will cooperate with the Faculty Hospital in Olomouc, Mayo Clinic and Eaton.

4. CONTRACT AMONG FACULTIES AND INSTITUTES

The content of the contract among faculties has not been agreed on yet.

5. INTERNAL BUDGET AND FINANCIAL STRATEGY

ZH and OV presented a structure of the financial strategy document that will be used for internal purposes (i.e. CIIRC employees).

The budget described in the document applies to a budget of individual departments, not groups.

RIV points will be divided based on the CTU methodology.

The document will be ready by February 15, 2015.

The CIIRC treasurer will nominate members of the working group regarding the financial strategy (M.

Sebek, V. Hlavac, H. Krautwurmova, P. Mikesova, T. Pajdla).

The document will be shared using the google application.

6. NEW WEB DESIGN

VH: V. Hlavac, O. Velek, J. Seguin, D. Vecerka, and J. Kreps met a graphic designer Mr. Soukup and agreed to pay 20 thousand for a technical proposal for the CIIRC web pages.
