1. POSSIBLE CHANGES TO THE MEETING AGENDA

The agenda was unanimously approved.

2. MINUTES OF THE PREVIOUS MEETING AND TASK REVIEW

• The MoM of CIIRC Assembly No. 40 - 42 were unanimously approved.

3. PROPOSAL OF KUČERA, MAŘÍK AND HANZÁLEK TO RECTOR TO BECOME A FACULTY

- This proposal should be presented to all CIIRC employees
- VM has informed assembly members on the current situation with RICAIP project and the related autonomy of CIIRC. RICAIP committee suggested three potential solutions

 CIIRC transformation into faculty, setting up VVI by the government, setting up VVI by other legal entity
- "Předběžný návrh na transformaci CIIRC na Fakultu" (Preliminary proposal of CIIRC transformation into faculty) - submitted by VM – unanimously approved by the Assembly

4. WORKING GROUP OF AS CTU AND CIIRC

- Assembly has identified the following use cases:
- o Explain to AS the structure of academic bodies of CIIRC
- Adjust the mechanism of personnel decisions concerning Institutes to ensure their stability
- o Clarify and document the financing CIIRC construction
- Clarify the reasons for removal of CIIRC director

5. DECLARATION OF CIRC ASSEMBLY -

- CIIRC Assembly responds to rector's statement in Czech Television (original text in Czech follows) and declares that CIIRC Assembly was not familiarized with the reasons why prof Mařík was removed from the position of CIIRC director in spite of the repeated promises from rector Vojtěch Petráček.
- V pořadu CT24 rektor CVUT Petráček prohlásil: ""Jistě neočekáváte, že budu na veřejnosti řešit detaily důvodů (odvolání profesora Maříka z funkce ředitele CIIRC), které jsou interní záležitostí školy a všichni zainteresovaní jsou s nimi seznámeni. Jako uvnitř organizace."

- Financial plan is balanced approved unanimously by the Assembly
